If subsequently it is discovered that the Purchaser is not entitled to any cash rebate(s), the Purchaser shall forthwith upon demand by the Vendor refund the relevant cash rebate(s) to the Vendor.

In such event, if any of the designated gift, financial advantage or benefit being cancelled and/or withdrawn by the Vendor has already been provided or given by the Vendor to the Purchaser, the Purchaser shall return and/or refund such designated gift, financial advantage or benefit to the Vendor forthwith. The Purchaser shall not be entitled to any compensation therefor. In case of dispute, the Vendor's decision shall be final and binding on the Purchaser.
